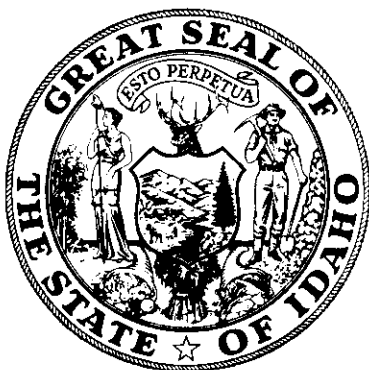

ARTICLES OF INCORPORATION

OF

SUNFRESH IDAHO COMPANY

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

Article I.

NAME. The name of the corporation is Sunfresh Idaho Company.

Article II.

DURATION. The period of its duration is perpetual.

Article III.

PURPOSE. The purpose for which the corporation is organized is: to purchase and prepare food products for distribution; to trade for agricultural products; and to engage in all other business transactions not forbidden by law.

Article IV.

STOCK. The aggregate number of shares which the corporation shall have authority to issue is 100 with a par value of \$250.00 per share.

Article V.

PREEMPTIVE RIGHTS. Provisions denying preemptive rights are: None

Article VI.

INTERNAL AFFAIRS. Provisions for the regulation of the internal affairs of the corporation are: None

Article VII.

REGISTERED OFFICE AND REGISTERED AGENT. The address of the initial registered office of the corporation is 9th and Dearborn Streets, P. O. Box 640, Caldwell, Idaho 83605, and the name of its initial registered agent as such address is Patrick J. Kole.
