The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is: Stratford Modular Structures, Inc.
SECOND: The period of its duration is perpetual.
