ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that the undersigned incorporators, all of the age of twenty-one years or more, desiring to organize a corporation under the Idaho Code, 1947, as amended, make, sign and verify these Articles of Incorporation.

ARTICLE I: The name of the corporation is:

CABLEGATION CONTROLS, INC.

ARTICLE II: The period of its duration is:

PERPETUAL.

ARTICLE III: The purpose or purposes for which the corporation is organized are:

TO ENGAGE IN THE BUSINESS OF MANUFACTURING, PRODUCTION, ASSEMBLAGE, FABRICATION, REPAIR, INSTALLATION, SERVICE AND SALE OF FARMING AND IRRIGATION EQUIPMENT.

TO ENGAGE IN ANY ACTIVITY OR BUSINESS PERMITTED UNDER THE LAWS OF THE UNITED STATES AND THE STATE OF IDAHO.

ARTICLE IV: The aggregate number of shares which the corporation shall have the authority to issue is:

TWENTY-FIVE THOUSAND (25,000) SHARES OF A PAR VALUE OF \$1.00 EACH.

ARTICLE V: Cumulative voting of shares of stock is authorized.

ARTICLE VI: Provisions granting to shareholders preemptive rights to acquire additional or treasury shares are:

ALL PREEMPTIVE RIGHTS ARE RESERVED TO THE SHAREHOLDERS.

ARTICLE VII: The address of the initial registered office of the corporation is:

ROUTE 1, BOX 356, WENDELL, IDAHO 83355

and the name of the initial registered at such address is:

ROBERT R. SMITH.

ARTICLE VIII: Address of the place of business is:

ROUTE 1, BOX 356, WENDELL, IDAHO 83355.

ARTICLE IX: The Directors shall have the power to make by-laws and to amend or alter the by-laws from time to time as they deem proper for the administration and regulation of the affairs of the Corporation.

ARTICLE X: The right is reserved from time to time to amend, alter or repeal any provision of and to add to these Articles of Incorporation in any manner now or hereafter prescribed or permitted by the laws of Idaho, and the right of all shareholders are subject to the reservation.

ARTICLE XI: The number of Directors constituting the initial Board of Directors is three (3), and the names and addresses of the persons who are to serve until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
