

This Plan of Merger is made and effective the date first above written by and between Kirk Life Estate LLC ("Dissolved Entity") and Kirk Meadows LLC ("Surviving Entity").

RECITALS

- A. Dissolved Entity and Surviving Entity are owned and controlled by the same Members.
- B. Each Member's interest in the profits and losses of and right to distributions from the Dissolved Entity and the Surviving Entity are the same.
- C. The Members wish to merge Dissolved Entity into Surviving Entity.

PLAN

- 1. Effective on the close of business May 31, 2017 ("Effective Date") and the filing of the appropriate documents with the Idaho Secretary of State, Kirk Life Estate LLC shall be merged into Kirk Meadows LLC and thereby be dissolved.
- 2. Surviving Entity shall succeed to all the assets of Dissolved Entity and assume and be obligated for all the liabilities of Dissolved entity. The Assets and Liabilities of Dissolved Entity as of the Effective Date are set forth on the Balance Sheet attached hereto as Exhibit A.
- 3. Surviving Entity shall diligently pursue the change of titled assets to Kirk Meadows LLC from Kirk Life Estate LLC and Dissolving Entity shall execute all and any assignments or deeds to consummate the change of title.
- 4. This document may be executed in counterparts.




