## ARTICLES OF INCORPORATION

OF

## RAUCH LUMBER COMPANY

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all being bona fide natural born citizens of the United States of America, over the age of twenty-one years, do, under and in pursuance of the general corporation laws of the State of Idaho, hereby organize, constitute and associate ourselves, and such other persons as may hereafter become associated with us, into a body politic and corporate, and to that end execute the following ARTICLES OF INCORPORATION, and we hereby set forth and declare as follows:

I.

That the name of this corporation is, and shall be, RAUCH  
LUMBER COMPANY.

## II.

That the purposes for which this corporation is formed are

as follows:

To manufacture, produce, purchase or otherwise acquire, to mortgage, pledge, sell, assign and transfer, or otherwise dispose of, import, export, distribute, invest, trade, deal in and with, either as principal or agent, goods, wares, merchandise and materials of every kind or description whether now known or to be hereafter discovered or invented, including but not limited to personal property, and including but not limited to every kind, class and description.

To engage in, do and transact a lumber, building

1 materials and forest products business in any and all of its branches; to buy or  
2 otherwise acquire and sell or otherwise dispose of, and in any manner deal in,  
3 with, and process trees, logs, lumber, timber, wood and the products of  
4 forests, of any and all kinds, and the chemical components thereof, in any and  
5 all states, in any form or condition, whether felled, standing or growing, and  
6 in any and all worked, built, manufactured or made shapes, articles or  
7 structures. To purchase, or otherwise acquire, build, construct, own, hold,  
8 take on lease, rent, use, operate, lease, let, sell, convey, mortgage, or  
9 otherwise dispose of, and in any manner deal in and with lands, timber,  
10 logging operations, lumber mills, saw mills, planing mills, kilns and other  
11 works, machinery, plants and equipment for harvesting, sawing, planing,  
12 veneering, drying and processing wood, forest products, and lumber  
13 products; felling, hauling or otherwise transporting, cutting, dressing,  
14 treating, working and hauling trees, logs, lumber, timber, wood, forest  
15 products, in any and all forms and for any and all purposes. To borrow or  
16 raise money for any of the purposes of the corporation and from time to time,  
17 without limit as to amount, to draw, make, accept, endorse, execute and  
18 issue promissory notes, drafts and bills of exchange, warrants, bonds, de-  
19 bentures and other negotiable or non-negotiable instruments and evidences of  
20 indebtedness for any of the objects or purposes of the corporation and to secure  
21 payment of any thereof and the interest thereon by mortgage upon or pledge,  
22 conveyance or assignment in trust of the whole or any part of the property of  
23 the corporation and to sell, pledge or otherwise dispose of such bonds or other  
24 obligations of the corporation for its corporate purposes.

26 To receive, acquire, hold, purchase, dispose of, convey,  
27 mortgage and/or lease, real and personal property; to dispose of, sell, lease,  
28 assign, transfer, mortgage and/or convey any rights, privileges, franchises,  
29 real or personal property of the corporation, other than its franchise of being

1 a corporation, and to acquire, purchase, guaranty, hold, mortgage, own, vote,  
2 sell, pledge and/or otherwise dispose of and deal in shares, bonds, securities  
3 and debentures and other evidences of indebtedness of other corporations,  
4 domestic or foreign.

5 To appoint such officers, employees and agents as the  
6 business of the corporation may require and to allow them compensation.

7 To enter into contracts or obligations of any type or kind,  
8 essential, necessary or proper to the transaction of the ordinary affairs, or for  
9 the purposes of the corporation.

28 nonassessable.
