ARTICLES OF INCORPORATION

The undersigned desired to form a corporation pursuant to the laws of the State of Idaho. The corporation will be a C - Type corporation. Having signed and sworn to this certificate, certify as follows:

- 1) **The name of the corporation:** *VIRTUAL Science Services, Incorporated.*
- 2) **The period of duration:** October 1, 2001 to unknown future date. (The corporation is to have a perpetual existence.)
- 3) **The type of business:** The character of the business of the corporation is to provide Scientific and Engineering Support Services.


