


Certificate of Municipal Incorporation

AN ORDINANCE PROVIDING THAT ALL BY-LAWS, ORDINANCES AND RESOLUTIONS LAWFULLY PASSED AND IN FORCE IN THE CITY OF ROCKLAND, IDAHO UNDER ITS FORMER ORGANIZATION AS A VILLAGE, SHALL REMAIN IN FULL FORCE AND EFFECT UNTIL ALTERED OR REPEALED BY THE MAYOR ANC COUNCIL; AND PROVIDING THAT THE PASSAGE OF HOUSE BILL #3, AS AMENDED, OF THE THIRTY-NINTH SESSION OF THE LEGISLATURE OF THE STATE OF IDAHO SHALL NOT IMPAIR OR AFFECT ANY ACT DONE, OFFENSE COMMITTED OR RIGHT ACCRUED, ACCRUING OR ACQUIRED OR LIABILITY, PENALTY, FORFEITURE OR PUNISHMENT INCURRED, BY THE VILLAGE OF ROCKLAND, IDAHO, PRIOR TO THE EFFECTIVE DATE OF SAID ACT AND THAT THE PASSAGE OF SUCH ACT SHALL HAVE NO EFFECT THEREON.

WHEREAS, pursuant to the provisions of H. B. #3, as amended, of the Thirty-Ninth Session of the Legislature of the State of Idaho, the persons constituting the Board of Trustees of the Village of Rockland, Idaho, reorganized by the election of a Mayor and a President of the Council of the City of Rockland, Power County, Idaho.

WHEREAS, H. B. #3, as amended, of the Thirty-Ninth Session of the Legislature of the State of Idaho, provides that all by-laws, ordinances and resolutions lawfully passed and in force in any City under its former organization as a Village shall remain in full force and effect until altered or repealed by the Mayor and Council under the provisions of such Act; and

WHEREAS, H. B. #3, as amended, of the Thirty-Ninth Session of the Legislature of the State of Idaho, provides that the passage thereof shall not impair or effect any act done, offense committed or right accruing, accrued or acquired or liability, penalty, forfeiture or punishment incurred by the Village of Rockland, Idaho prior to the effective date of such Act and that the passage of such act shall have no effect thereon.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF ROCKLAND, IDAHO, AS FOLLOWS:

Section 1. All by-laws, ordinances and resolutions lawfully passed and in force in the City of Rockland, Idaho, under its former organization as a Village, shall remain in full force and effect until altered or repealed by the Mayor and Council of said City, as provided by H. B. #3, as amended, of the Thirty-Ninth Session of the Legislature of the State of Idaho.

Section 2. The passage of H. B. #3, as amended, of the Thirty-Ninth Session of the Legislature of the State of Idaho, shall not impair or effect any act done, offense committed or right accruing, accrued, or acquired or liability, penalty, forfeiture or punishment, incurred by the Village of Rockland, Idaho, prior to the effective date of such act, but the same may be enjoyed, assetted, enforced, prosecuted or inflicted by the City of Rockland, Idaho, as fully and to the same extent as if such act had not been passed.
