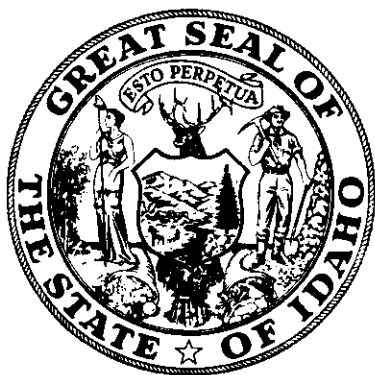

ARTICLES OF INCORPORATION
OF
GEOSCIENCE RESOURCES, INC.

The undersigned, acting as incorporators under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is Geoscience Resources, Inc.

ARTICLE TWO

DURATION

The duration of the corporation shall be perpetual.

ARTICLE THREE

PURPOSES AND POWERS

The purposes of the corporation and its powers are the following:

1. To own, manage, operate, exploit and develop real property and natural resources of all types, and to do all things necessary, proper, conducive or incidental thereto.

2. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE FOUR

STOCK

The aggregate number of shares which the corporation shall have authority to issue is 100 in number and shall be of One and No/100ths Dollar (\$1.00) par value. Said shares of stock shall be fully paid for before being issued, and after issuance shall be nonassessable.

ARTICLE FIVE

LOCATION

The location and address of the initial registered office of the corporation is 1084 North Skyline Drive, Two Airport Plaza, Idaho Falls, Idaho 83401 and the name of its initial registered agent at such address is Roger C. Stoker.


