KNOW ALL MEN BY THESE PRESENTS: That we the undersigned, all of whom are natural persons of lawful age, and citizens of the United States and residents of the State of Idaho, and associated together as members of the First Baptist Church of Paul, Idaho, a religious organization of which pecuniary profit is not an object, in accordance with the rules, regulations, laws and discipline of such organizations, and for the purpose of forming a religious corporation under the laws of the state of Idaho, do now, on this 14th day of March, 1962, hereby voluntarily associate ourselves together, and do hereby make and execute the following Articles of Incorporation, and do hereby certify as follows, to-wit:

FRTICLE I

The name of this corporation shall be First Baptist Church of Paul, Idaho, Inc.

ARTICLE II

The duration of this corporation shall be perpetual.

ARTICLE III

The location and post office address of the registered office of this corporation, and the place where the principal business of this corporation is to be transacted is Paul, Idaho, Post Office Box 251.

ARTICLE IV

The purpose for which the corporation is formed and is to be conducted is to give corporate existance to the members of the Church, a religious organization known as the First Baptist Church

of Paul, Idaho, for the sole purpose of operating a Church; to purchase, hold, lease, rent, sell or mortgage real property for the purposes of owning and operating, conducting and carrying on said religious organization and to do all things necessary; to purchase, take, hold, lease, rent, sell or mortgage personal property for the purpose of owning or operating a religious organization, and to do all things incidental, necessary or convenient in the carrying out of the foregoing purposes.

The above enumerated purposes shall also be considered as a statement of powers, and this corporation may do each and every thing suitable or proper for the accomplishment or attainment of any one or more thereof, or conductive to, or expedient for, the interest or benefit of the corporation. In addition thereto, the corporation shall have, and may exercise any other or further rights, powers and privileges granted by law to corporations of a religious character.

ARTICLE V

Pecuniary profit is not the object of this corporation and it shall have no capital stock. The government of this corporation and the management of its affairs shall be vested in a board of five trustees, all of whom shall be duly elected, qualified and acting officers of the First Baptist Church of Paul, Idaho.

The Board of Trustees shall be elected from their own number and shall serve for such period of time that may be provided in the By-Laws of the corporation.

ARTICLE VI

All real and personal property heretofore owned by the First Baptist Church of Paul, Idaho, shall be and become the

property of this corporation, and title to all of said property shall pass immediately to and become vested in this corporation.

FRTICLE VII

That a duly called meeting of the members of the First Baptist Church of Paul, Idaho, was held in the Church building in the village of Paul, County of Minidoka, state of Idaho, which said Church building is the meeting place where the members and congregation of said Church regularly meet, and which said meeting was held on the 14th day of March, 1962, at the hour of 8:00 o'clock P.M. of said day, at which meeting a majority of the members who were present voted for the election of trustees; that due and regular notice of the time and place of holding such meeting and election was given by publication thereof for more than two weeks, on the following dates, to-wit: March 1 and March 8, 1962, in the Minidoka County News, a newspaper published and of general circulation in Paul, Minidoka County, Idaho, the city where said election was held, and was published in every issue above named, and by posting a like notice in a conspicuous place on the front door of the building where such election was held, for more than two weeks prior to said meeting, said notice having been posted at all times from posting date of February 22, 1962, until the time of said election; that notice was also given each and every member of the First Baptist Church of Paul, Idaho, of said meeting and election and that the question of incorporation of said Church was to be considered at said meeting, and at said meeting the following persons were duly elected and qualifed as Trustees and the officers of the said First Baptist Church of Paul, Idaho, to-wit: Alvin Renz, Wilman Dawson, both of Paul, Idaho; and Harold Marler, Carl Smith and Merrill Pasley of Haselton, Idaho.

ARTICLE VIII
