ARTICLES OF INCORPORATION

OF

MERRILL'S POULTRY FARM, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, citizens and residents of the United States of America, and each over the age of 18 years do by these presents voluntarily associate ourselves together for the purpose of forming a corporation, as hereinafter stated, pursuant to and under the laws of the State of Idaho, and do hereby execute and deliver these Articles of Incorporation for that purpose.

We hereby set forth, declare and certify:

ARTICLE I

NAME

This corporation shall be known as "MERRILL'S POULTRY FARM, INC.".

ARTICLE II

OBJECTS AND PURPOSES

The objects and purposes for which this corporation is formed are as follows:

- (a) To own, operate, and manage poultry raising operations, including all aspects of sales and purchase of the same, and including production and sale of all poultry products together with any other lawful agricultural pursuit or undertaking.
- To engage in any commercial, industrial and agricultural enterprise, calculated or designed to be profitable to this corporation, and in conformity with the laws of the State of Idaho.
- To generally engage in, do and perform any lawful enterprise, act or vocation that a natural person might, or could do or perform.
- To purchase, lease, own, sell, mortgage, sublease and otherwise acquire lands, buildings, easements, or property, real or personal, which may be requisite for the purposes or capable of being conveniently used in connection with any of the objects of this corporation, and to enter into, make, perform and carry out contracts of every sort and kind, with any person including the right to become a partner and to acquire and take over the

good will, property, rights, franchises, and assets of every kind, and the liabilities of any person, firm, association, or corporation, either wholly or in part, and to pay for the same in cash, stocks, bonds of the corporation or otherwise. The corporation is also authorized to guarantee the debts of another.

- To conduct and carry on the business of buying, (e) selling and dealing in all kinds of grain, hay, or any other farm produce and farm products, livestock, and provisions, and all other kinds of goods, wares, and merchandise, and to do a general commission and brokerage business in any or all of the foregoing kinds of property.
- To do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes and the attainment of any of the objects, or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act, or acts, thing or things, incidental or pertinent to or growing out of, or connected with the aforesaid objects and purposes, or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized.

ARTICLE III

LOCATION

The location and post office address of the registered office of this corporation is Route #2, Paul, Minidoka County, Idaho.

ARTICLE IV

CORPORATE EXISTENCE

The term and existence of this corporation shall be perpetual.

ARTICLE V

CORPORATE STOCK

The total authorized number of shares of stock and the par value thereof shall be as follows:

dends declared by the Board of Directors; each shareholder of common stock of record shall be entitled at all meetings of the corporation, or in matters requiring a vote, to one (1) vote for each share of stock standing in his name upon the books of the corporation.

The holder of shares of any class of this corporation shall, upon the sale by authorization of the corporation, for cash or shares of the same class, have the right, during a reasonable time to be fixed by the Board of Directors, to purchase shares in proportion to their respective holding of shares of such class, and such price as may be fixed therefore by the Board of Directors, but at not less than par for par value shares.

The corporation may purchase its own stock.

All stock when fully paid shall be non-assessable.

No sale or transfer of stock may be made without a prior offer in writing to the remaining stockholders in the same proportion as their shareholdings, and at the same price, terms and conditions on which the prospective transfer is predicated.

ARTICLE IX

AMENDMENT

These Articles of Incorporation may be amended in accordance with the provisions of the statutes of the State of Idaho, then in full force and effect; the power to make, repeal, and amend the By-Laws and adopt new By-Laws is hereby conferred upon the directors, as well as the shareholders.

ARTICLE X

No contract, lease or other transaction between this corporation or any other corporation, whether or not the majority of shares of capital stock of such corporation are owned by this corporation, and no act of this corporation shall in any way be affected or invalidated by the fact that any of the directors of this corporation are pecuniarily or otherwise interested in or are directors or officers of such other corporation; any director, individually, may be a party or may be pecuniarily or otherwise interested in any contract, lease or other transaction of this corporation and any director of the corporation who is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation which shall consider such contract or transaction and may vote thereon with like force and effect as if he were not so interested.
