## ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a Corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such Corporation:

Ι

The name of the Corporation is INLAND EMPIRE PROFESSIONAL ADJUSTERS, INC.

II

The period of duration of this Corporation shall be perpetual.

III

The purpose or purposes for which the Corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

IV

The aggregate number of shares the Corporation shall have authority to issue is 10,000 shares, all of which are to be of no par value.

V

No stock of the Corporation shall be transferred to a person who is not already a stockholder unless the stock shall have been first been offered in writing for sale to each of the other stockholders of the corporation. Regulations as to the procedure


