ARTICLES OF INCORPORATION

We, the undersigned, for the purpose of forming a corporation under and pursuant to the provisions of the laws of the State of Idaho, for the purpose expressed in ARTICLE II hereof, do hereby adopt the following Articles of Incorporation:

### ARTICLE I.

The name of this corporation shall be THE OROFINO INDUSTRIAL ARTS AND WOODWORKERS GUILD, INC.

#### ARTICLE II.

The objects of this corporation are:

- A. To form a non-profit corporation to promote the industrial arts and woodshop program in the Orofino area, particularly in the Orofino High School both on an adult and High School level.
- B. To encourage and promote the citizens of the community to participate in and to support the industrial arts and woodshop program at the Orofino High School.
- C. To encourage scholarships, loans, or other programs designed to assist worthwhile needy students to purchase supplies and/or materials to enable them to express their creative, artistic, and craftsman-like skills in an industrail arts and woodshop program at Orofino High School.
- D. To purchase, acquire and solicit by donation equipment, tools or supplies to benefit the industrial arts program at the Orofino High School.

- E. To promote adult woodshop classes to encourage the co-operation between adults and students to engender community and student pride in the craftsman skills in woodworking and industrial programs as may be now offered or developed in the Orofino High School. Further, to contract with or to provide the necessary support to offer adult classes in the locational area.
- F. For any other lawful purpose and power in keeping with the nature of this corporation as permitted by Idaho Law for non-profit corporations.

# ARTICLE III.

This corporation shall be a non-profit corporation having one class of members whose membership shall be open to all youth and adults in the Orofino, Idaho area upon the payment of such dues and fees as set forth in the By-Laws of this corporation. Each person holding membership shall be entitled to one vote.

## ARTICLE V.

The location of the corporation's registered office office shall be at 139 Johnson Avenue and the said agent to be found at such address is John A. Swayne, whose mailing address is P.O. Box 786, Orofino, Idaho 83544.

#### ARTICLE VI.

The names and post office addresses of the incorporators and first directors of the corporation are as follows:

The above named three incorporators will be directors and will hold office until their successors shall have been

elected and qualified, or until he shall die, resign or shall have been removed as provided for in the By-Laws.

#### ARTICLE VII.

In the event of dissolution of this corporation, any funds, property of any nature having accumulated or owned by this corporation shall be, after the payment of any outstanding indebtedness of said corporation, be distributed to the Orofino Idaho High School for the purposes of use of the industrail arts or shop program.
