**AMENDED ARTICLE IV
MEMBERS AND MEMBERSHIP**

3. Transferred Membership. Membership in the Association shall not be transferred, pledged, or alienated in any way except upon the transfer of ownership of the Lot to which it is appurtenant, and then only to the new Owner. Membership in the Association shall not be increased in any number greater than the number of Lot Owners totaling a numerical value of seven (7) as of December 07, 1999. Membership in the Association shall not be transferred, pledged, subdivided, and/or alienated in any form through the division of an existing Membership Lot. Any attempt to make a prohibited transfer is void. In the event the Owner of any Lot should fail or refuse to transfer the membership registered in its name to the purchaser of its Lot, the Association shall have the right to record the transfer upon its books and thereupon the old membership outstanding in the name of the seller shall be null and void.
