ARTICLES OF INCORPORATION

KISER, PEEHL, PIPKIN & ASSOCIATES, INC.

Pursuant to the provisions of Sections 330-1-61 of the Idaho Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Kiser, Peehl, Pipkin & Associates, Inc.

SECOND: The following amendments of the Articles of Incorporation were adopted by the Board of Directors of the corporation on May 14, 1982, in a manner prescribed by the Idaho Business Corporation Act:

RESOLVED, that the name of this corporation be changed to KISER - PIPKIN REAL ESTATE , INC.

THIRD: The number of shares of the corporation outstnding at the time of such adoption was two hundred (200); and the number of shares entitled to vote thereon was two hundred (200).
