ARTICLES OF INCORPORATION OF

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being of legal age and being citizens of the United States of America and residents of the State of Idaho, do hereby as incorporators hereof, form a non-profit cooperative association under the laws of the State of Idaho, according to and in compliance with Title 30, Chapter 3, Idaho Code, and do hereby adopt Articles of Incorporation, as follows:

ARTICLE I.

NAME

The name of this corporation shall be BLACKFOOT COMMUNITY PLAYERS, INC.

ARTICLE II.

PURPOSES

The purpose for which this corporation is formed is as follows:

To encourage and foster dramatic art and public interest in the legitimate theatre, to develop amateur dramatic talent; to lease, rent, or purchase and own, establish, maintain and operate a theatre for the production of plays in which the community may take part as actors, producers, managers and in such other capacities as shall be requisite or necessary; to encourage play-writing by its members and others; to acquire and take by purchase, gift, devise and bequest, subject to the provisions of law relating to devises and bequests, or otherwise; to lease,

buy, sell, use, hold and transfer all such property, real and personal, as may be necessary or convenient for attaining the objects and carrying into effect the purposes of the corporation; and to do whatever properly may be done incidental to such purpose.

ARTICLE III.

PRINCIPAL PLACE OF BUSINESS: REGISTERED AGENT

The post office address of the registered office of the corporation is P. O. Box 266, ^{545 North Broadway,} City of Blackfoot, County of Bingham, State of Idaho, 83221. The name of the corporation's registered agent and registered agent's address is: Wayne Harris, City of Blackfoot, County of Bingham, State of Idaho 83221.

ARTICLE IV.

DURATION

The duration of this corporation shall be perpetual.

ARTICLE V.

MEMBERS

This corporation is organized without capital stock, and the rights and interests of all its members shall be equal. The qualifications for membership shall be provided in the By-Laws.

ARTICLE VII.

BOARD OF DIRECTORS

ARTICLE VIII.

LIMITATION OF EXPENDITURES AND ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and

distributions in furtherance of the purposes set forth in Article II. hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statement) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE IX.

DISSOLUTION

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Law, as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the District Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as

said court shall determine, which are organized and operated exclusively for such purposes.
