The undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for this corporation:

I.

The name of this corporation shall be Knowledge Impact, Inc.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The address of the initial registered office of corporation shall be 2402 North 28th Street, Boise, Idaho 83703 and the name of the initial registered agent at such address is Dian Hoffpauir.

IV.

The nature of the business and the object and purpose of this corporation shall be as follows: To engage in the information brokerage business providing information research, staff training and data organization services; and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

V .

The total authorized capital of this corporation shall consist of one thousand (1,000) shares each of a par value of one dollar (\$1.00) and of the aggregate par value of one thousand dollars (\$1,000.00), which said shares shall be voting common stock and shall not be subject to assessment.

VI.

The name and post office address of the incorporator is as follows:

The first Board of Directors shall consist of one director, but during her term of office, or thereafter, the number of directors shall be as set forth in the By-Laws of the corporation; provided, however, that the number of directors constituting a Board shall be not less than one (1) nor more than five (5).
