ARTICLES OF INCORPORATION  
OF  
MILES BUS COMPANY

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, being natural persons of legal age and acting as incorporators of a corporation, under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

**FIRST:**

The name of the Corporation is MILES BUS COMPANY.

**SECOND:**

The period of its duration is perpetual.

**THIRD:**

The purpose or purposes for which the corporation is organized are: transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

**FOURTH:**

The aggregate number of shares which the corporation shall have authority to issue is five thousand (5,000) shares with a par value of One Dollar (\$1.00) per share. There shall be one class of shares, all of which shall be common shares.

FIFTH:

The address of the initial registered office of the Corporation is Route 6, Box 326, Blackfoot, Idaho, and the name of the initial registered agent at such address is FRANK J. MILES.


