The undersigned, in order to form a Corporation under the provisions of Title 30,  
Chapter 1, Idaho Code, submits the following articles of incorporation:

**ARTICLE I**

The name of the corporation is Titan Consulting, Incorporated.

**ARTICLE II**

The purpose or purposes of the corporation shall be:

To engage in providing sales and marketing services to individuals and organizations  
requiring same;

To engage in and do any lawful act concerning any and all lawful business for which  
corporations may be organized under the Idaho Code and any amendments thereto.

**ARTICLE III**

The corporation shall have authority to issue One Thousand (1,000) shares of stock of no  
par value, which stock shall be of one class only, which shall be common voting stock.

liable to the corporation or its shareholders for monetary damage for an action taken or  
any failure to take any action, as director.

these Articles of Incorporation inconsistent with this Article IV, shall eliminate or reduce  
the effect of this Article IV in respect of any matter occurring or any cause of action, suit  
or claim that, but for this Article IV would accrue or arise prior to such amendment,  
repeal or adoption of an inconsistent provision.
