ARTICLE III. TERM

The term for which the Corporation is to exist is perpetual.

ARTICLE IV. INITIAL REGISTERED AGENT

ARTICLE V. INCORPORATOR

common stock and shall be non-assessable, except that shares of non-voting common stock shall not be entitled to vote.
