

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF IDAHO JUNIOR BALLET THEATRE, INC.

Pursuant to the provisions of §30-327 of the <u>Idaho Code</u>, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:
