



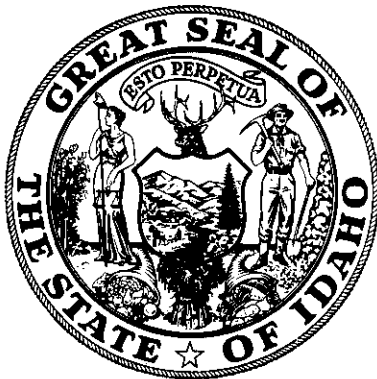
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION  
OF  
NEW GENERATIONS MARKETING, INC.

KNOW ALL MEN BY THESE PRESENT: That we, the undersigned natural persons of lawful age and citizens of the United States, for the purpose of forming a corporation pursuant to the provisions of the Idaho Business Corporation Act (Title 30, Idaho Code) do hereby certify as follows:

I

The name of the corporation is:

NEW GENERATIONS MARKETING, INC.

II

The corporation is to have perpetual existence.

III

The purpose and objectives for which the corporation is organized include the transaction of any or all lawful business for which corporations may be allowed under the Idaho Business Corporation Act (Title 30, Idaho Code).

IV

The aggregate number of shares which the corporation shall have authority to issue is: 1,000. Such shares are to consist of one class only, and shall be issued pursuant to

the provisions of Section 1244 of the Internal Revenue Code. The par value of each of the shares shall be \$1.00 (ONE AND 00/100THS DOLLARS), which stocks shall not be issued until fully paid for, and once so issued shall be nonassessable.

#### V

All of the shares of stock issued shall be common stock, and all shares shall have equal value, without preference, limitations or differences in relative rights with respect to other shares.

#### VI

Stockholders of the corporation shall have preemptive and preferential rights of subscription to any shares of stock of the corporation, whether now or hereafter authorized, or to any obligation convertible into stock of the corporation, or to obligations of the corporation convertible into stock. Any stock or obligations issued by the corporation shall first be offered to the stockholders of the corporation.
