ARTICLES OF INCORPORATION OF MOTOR MANAGEMENT, INC.

KNOW ALL MEN BY THESE PRESENTS: That Jeffery W. Hollenbeck, the undersigned, being a natural person of legal age and a citizen of the United States of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the laws of the State of Idaho, sees hereby certify as follows:

I.

<u>Name</u>

The name of the corporation shall be Motor Management, Inc..

II.

<u>Duration</u>

The period of existence and duration of the corporation shall be perpetual.

III.

Corporate Purpose

The purpose for which the corporation is organized shall be the transaction of any and all lawful business for which corporations may be incorporated under the laws of Idaho.

ARTICLES OF INCORPORATION - 1

Authorized Capital Stock

The corporation shall have 100 shares of no par value common stock. Each share shall have the same rights, privileges and voting power and shall be non-assessable.
