



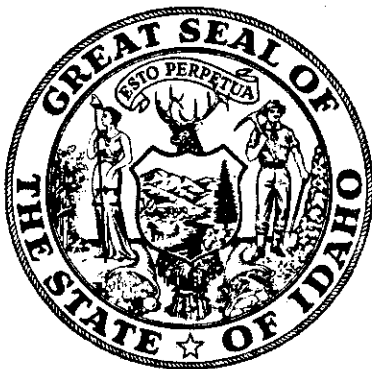

The plan of merger was adopted by the Board of Directors of Twin Falls Livestock Commission Co., and Twin Falls Livestock Land Co. The name of the surviving corporation is Twin Falls Livestock Commission Co.

1. Name. The name of each corporation is as follows: Twin Falls Livestock Commission Co., and Twin Falls Livestock Land Co.

2. Authorized Shares. The number of outstanding shares of Twin Falls Livestock Commission Co., is 100 shares of no par value. The number of outstanding shares of Twin Falls Livestock Land Co., is 100 shares of no par value.

3. Filing of Certificates of Incorporation. The Certificate of Incorporation of Twin Falls Livestock Commission Co., was filed by the Idaho Secretary of State on the 27th day of March, 1964, and the Certificate of Incorporation of Twin Falls Livestock Land Co., was filed by the Idaho Secretary of State on the 10th day of June, 1982.

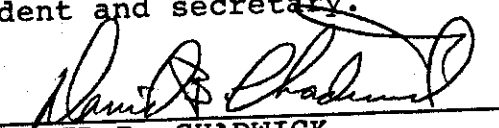

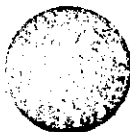
