Articles Amendment -

Addition to Purpose for The Coeur d'Alene Carousel Foundation, Inc.

- Art 2"This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code."
- Art 8"No part of the net carnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that of the corporation shall be authorized and empowered to pay resonable compensation for the services rendered and to make payments and distributions in futherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office."

"Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activies nor have purposes not permitted (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United states Internal Revenue Law)."
