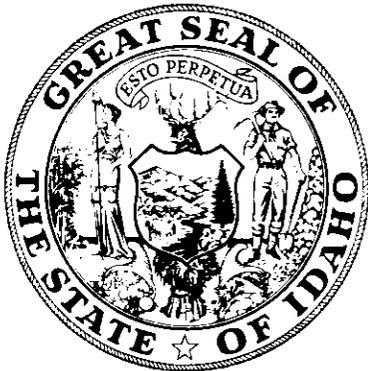

The notice required by Section 30-1-87, Idaho Code, was given as required by law.

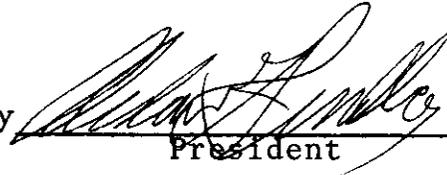
All debts, obligations, and liabilities of the corporation have been paid and discharged, or adequate provision has been made therefor.

All remaining property and assets of the corporation have been distributed to the Shareholders in proportion to their respective rights and interests.

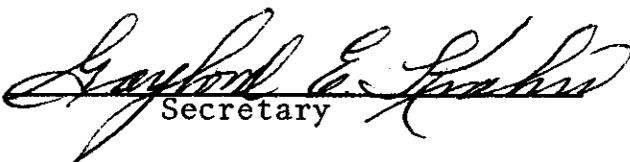
There are no suits pending against the corporation in any Court.

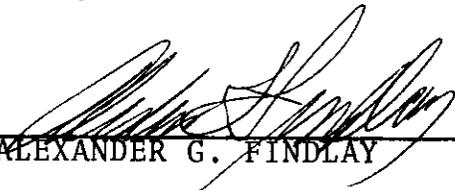
WRITTEN CONSENT OF SHAREHOLDERS

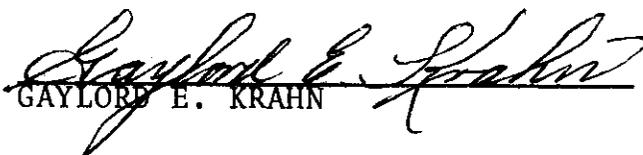
1. The name of the corporation is BROADWAY INVESTMENT COMPANY.

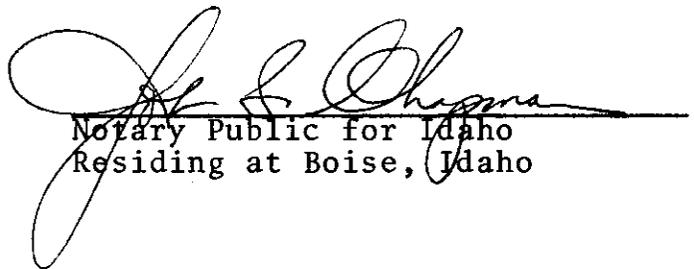
