ARTICLES OF INCORPORATION

OF  
SIGNWORKS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Article of Incorporation for such corporation.

1. NAME: The name of the corporation is SIGNWORKS, INC.
2. DURATION: The period of its duration is perpetual.
3. PURPOSES: The purpose or purposes for which the corporation is organized are the design, manufacture, sale and installation of signs, graphics and related business and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
4. SHARES AUTHORIZED: the aggregate number of shares which the corporation shall have authority to issue is ONE THOUSAND (1,000) shares of no par value common stock.
5. PRE-EMPTIVE RIGHTS: Shareholders shall have full pre-emptive rights to acquire unissued or treasury stock or securities convertible into or carrying a right to subscribe to or acquire shares.
6. BUSINESS AFFAIRS: Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the corporation's By-Laws, including restric-

tions on transfer of shares.
