



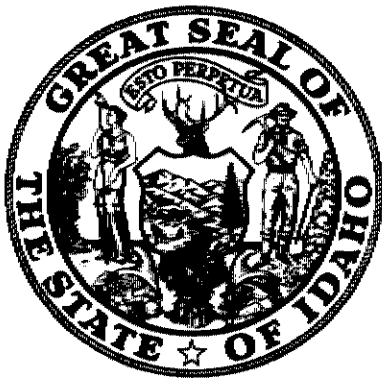
**CERTIFICATE OF INCORPORATION

The undersigned, in order to form a corporation pursuant to the Idaho Professional Service Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is James A. Gorczyca D.D.S., P.A. (hereafter "corporation").

ARTICLE II

The purposes for this Corporation is organized are as follows:

1. To engage in dentistry; and
2. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Professional Service Corporation Act.

ARTICLE III

The Corporation shall have perpetual existence.

ARTICLE IV

The address of the initial registered office of the Corporation shall be 230 W. Mallard Dr. Suite A, Boise, Idaho 83706, and the name of its initial registered agent at such address is James A. Gorczyca.

ARTICLE V

The shares of stock to be issued by the Corporation shall consist of one class only, and the aggregate number of shares which the Corporation shall be 100 shares of stock, each having a par value of \$1.00 per share. All shares of stock shall have the same rights in such Corporation and shall be non-assessable when paid in full.

ARTICLE VI
