THE COMMUNITY PRESBYTERIAN CHURCH (USA) OF KAMIAH, IDAHO, INC.

WE, the undersigned, do hereby form a non-profit corporation, Chapter 3, Title 30 of the Idaho Code, and do hereby certify and declare:

ARTICLE I: NAME. The name of this organization shall be The Community Presbyterian Church (USA) of Kamiah, Idaho, Inc.

ARTICLE II: NON-PROFIT, EXISTENCE. This corporation is organized as a non-profit corporation of the State of Idaho, and its length of existence shall be perpetual.

ARTICLE III: PURPOSE. The purposes of this corporation, formed without pecuniary interest, are to promote, conduct, provide for and carry on any and all activities in connection with the operation of a religious organization as a community church for the benefit and general welfare of the citizens of the community. The Corporation shall have the power to do anything not prohibited by law necessary or requisite for the furthering of the purposes of this corporation.

ARTICLE IV: MEMBERSHIP. The corporation shall not have nor issue any capital stock and all the rights and interest of each member shall be equal and no member may have or acquire a greater interest than any other member therein.

ARTICLE V: REGISTERED AGENT AND ADDRESS. Registered agent shall be Marian Pratt. The location and street address of the corporation's initial registered office shall be 608 Idaho Street, Kamiah, Idaho 83536 and the mailing address is P.O. Box 246, Kamiah, Idaho 83536.

ARTICLE VI: INCORPORATORS, DIRECTORS AND OFFICERS. The corporation shall have the following incorporators and directors, who shall also be officers as follows:

ARTICLE VII: AMENDMENT. These articles may be amended by quorum of the membership who are present at any meeting called by the Clerk after notice, as required by the appropriate provisions of the Idaho Code.

ARTICLE VIII: INTERNAL REVENUE CODE. This corporation is organized exclusively for religious, charitable, scientific, literary or education purposes within the meaning of Section 50l(c) (3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities permitted to be carried on by an organization exempt from federal income tax under Section 50l(c) (3) of the Internal Revenue Code.

Upon the winding up and dissolution of the corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its exempt status under Section 50l (c)(3) of the Internal Revenue Code.
