## ARTICLES OF AMENDMENT OF MID-WAY WATER CO., INC.

Amendment of Articles of Incorporation of Mid-Way Water Co., Inc., a non-profit corporation organized under the laws of the State of Idaho, executed by Kent C. Howell, its president and Lynn R. Bingham, its secretary.

- 1. The Corporation was organized on September 23, 1992.
- 2. The Corporation on the proposal of its Board of Directors by resolution and duly adopted by said Board of Directors setting forth the proposed amendment and directing that the same be submitted to a vote of the stockholders/members entitled to vote and respect thereof at a designated meeting of such stockholders/members, and on the adoption thereof by said stockholders/members at said meeting as provided by law, does hereby, by Kent C. Howell, its president and Lynn R. Bingham, its secretary, execute and acknowledge the following amendment additions to the Articles of Incorporation of Mid-Way Water Co., Inc.:

### ARTICLE XI

Upon dissolution of the Corporation, all remaining assets of the Corporation will be distributed to all persons who are stockholders/members during all or any part of the period in which the assets were held in proportion to the amount of business done with those members/stockholders or their assigns during that period of time insofar as it is practicable.
