ARTICLES OF INCORPORATION

OF

10-UP, INC.

Attorney, Corporation Division

I, the undersigned natural person of the age of eighteen (18) years or more, a citizen of the State of Texas, acting as Incorporator of a Corporation under the Texas Business Corporation Act, do hereby adopt the following Articles of Incorporation for such Corporation:

ARTICLE I

The name of the Corporation is 10-UP, INC.

ARTICLE II

The duration is perpetual.

ARTICLE III

The purpose or purposes for which the Corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Texas Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the Corporation shall have authority to issue is ONE MILLION SHARES of the par value of \$1.00 each, consisting of one class only.

ARTICLE V.

The Corporation will not commence business until it has received for the issuance of its shares consideration of the value of ONE THOUSAND DOLLARS (\$1,000.00) consisting of money, labor done, or property actually received, which sum is not less than ONE THOUSAND DOLLARS (\$1,000.00).

ARTICLE VI.
