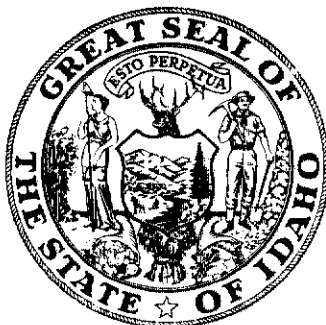

The undersigned incorporators, in order to form a non-profit corporation under the laws of the state of Idaho, adopt the following Articles of Incorporation:

ONE: The name of this corporation is EAGLES NEST MINISTRIES OF BLACKFOOT, INC.

TWO: The name and address of the corporation's initial registered agent and the registered office for service of process of this corporation are:

THREE: This corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law primarily for religious purposes. More specifically, the purpose of this corporation is to operate a church for the worship of Jesus Christ.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

SIX: The period of duration of this corporation is perpetual.

SEVEN: This corporation shall have no members.

EIGHT: Any additional provisions for the operation of the corporation are as follows:

The property of this corporation is irrevocably dedicated to religious purposes, and no part of the net income or assets of this organization shall ever inure to the benefit of a director or officer of the corporation, or to the benefit of any private individual.


Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation organized and operated exclusively for religious purposes and that has established its tax-exempt status under 501(c)(3) of the Internal Revenue Code.


No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
