

The undersigned, for the purpose of forming a corporation and refer the laws of the State of Idaho and particularly regarding insurance sales, do hereby adopt the following articles of incorporation.

# 1. MAKE

The name of the corporation is TCB, Inc.

#### 2. DURATION

The period of its duration is perpetual.

#### 3. PURPOSE

Its purpose is to transact, franchise and engage in the business of insurance sales as an agent and or agency with agents within the State of Idaho; and to engage in any other trade or business which, in the opinion of the sole shareholder as provided and authorized in the Shareholders' Management Agreement can be advantageously carried on in connection with or auxiliary to providing insurance sales.

#### 4. SEARES

It shall have authority to issue 3,000 shares, all in one class, of common stock issued at \$1.00 par value; said stock being further identified as small business stock pursuant to IRSC Section 1244.

## 5. REGISTERED OFFICE AND AGENT

The address of its initial registered office is 546 N. Capital, Idaho Falls, Idaho 83402. The name of its initial registered agent at such address is Thomas C. Bateman.

### 6. NO BOARD OF DIRECTORS

This corporation shall have no board of directors. The corporation shall be managed by its shareholder(s) pursuant to a shareholders' management agreement. Said agreement sets forth the voting and managerial rights of the shareholder(s) as akin to the rights vested in a board of directors of most other corporations. The

shareholders' management agreement specifies who will manage the affairs of the corporation, who will be the executive officer(s) and the vote necessary to approve actions specified in the agreement.

#### 7. INCORPORATION

#### 8. PREEMPTIVE RIGHTS

The holder(s) of outstanding common shares of the corporation's stock shall, to the extent provided by law, have preemptive rights to acquire unissued shares of stock, whether now or later authorized.

Except as otherwise provided in this section, an interest in the shares of the corporation may not be voluntarily or involuntarily transferred, by operation of law or otherwise.
