The undersigned, acting as an incorporator of the Corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such Corporation:

FIRST: The name of the Corporation is OBERDORFER HIGH-TEX, INCORPORATED.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the Corporation is organized are to manufacture, buy, sell, process, acquire, handle, market, store, import, export, deal in and with paper machine clothing fabrics for paper machines, whether made wholly or in part, of metal or plastic wires, or other materials now known or hereafter discovered; to carry on the business of manufacturers and fabricators of, and general dealers and distributors of such paper machine clothing and fabrics, and with other products of every kind and description in connection therewith, including the design thereof; and to own, lease, operate and maintain any and all plants, mills, factories, offices, warehouses, depots and other facilities of every kind and description necessary or incidental thereto.

This Corporation is also organized for the purpose of transaction of any and all lawful business for which Corporations

may be incorporated under the Idaho Business Corporation Act, including, but not limited to, all of the general powers as set forth in Idaho Code 30-1-4.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is one thousand (1,000) shares, with a par value of \$2.00 per share.

FIFTH: There are no provisions denying pre-emptive rights to shareholders.

SIXTH: The internal affairs of the Corporation shall be governed by a duly adopted code of bylaws which shall be consistent with these Articles of Incorporation and laws of the State of Idaho.
