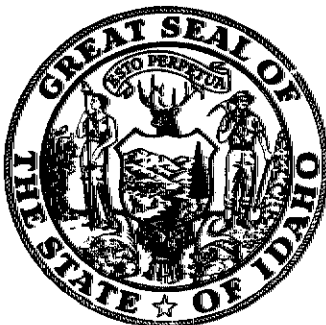

ARTICLES OF INCORPORATION

The undersigned, individuals, do form a Corporation in accordance with title 30 of the Idaho Code and do hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the Corporation is INIt, Inc.

ARTICLE II

The Corporation is to have perpetual existence.

ARTICLE III

The Corporation is organized for the purpose of engaging all lawful business for which Corporations may be incorporated under Idaho Law.

ARTICLE IV

The Corporation shall have the authority to issue one million (1,000,000) shares of one class of common stock. Each share shall have no par value.

ARTICLE X

The private property of the stockholders of the Corporation shall not be subject to the payment of corporate debts to any extent whatsoever, and the shares of the Corporation shall not be subject to assessment for the purpose of paying expenses, conducting business, or paying debts of the Corporation.

ARTICLE XI

The number of the Directors of the Corporation shall be as specified in the Bylaws, provided that the number of Directors of the Corporation shall not be fewer than the number required by law. In case of an increase in the number of Directors, the additional Directors may be elected by the Directors now in office, and the Directors so elected shall hold office until the next annual meeting of the shareholders and until their successors are elected and qualified.

ARTICLE XII

The Stockholders of the Corporation shall have pre-emptive and preferential rights of the subscription to any shares of stock with the Corporation whether now or hereafter authorized, or to any obligations of the Corporation convertible into stock.

ARTICLE XIII


No contract or other transaction between the Corporation and any other Corporation and no act of the Corporation shall in any way be

affected or invalidated by the fact that any of the Directors of the Corporation are pecuniarily or otherwise interested in, or are the Directors or officers of, such other Corporation; any Director, individually, or any firm of which any Director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of the Corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any Director of the Corporation, or is to be interested may be counted in determining the existence of the quorum at any meeting of the Board of Directors of the Corporation which shall authorize any such contract or transaction with like force and effect as if he were not such Director or officer of such other Corporation or not so interested.

ARTICLE XIV

The Corporation shall be governed as to its internal affairs by the bylaws of the Corporation kept at the registered office of the Corporation or the offices of its Attorney.




