5. The agreed contributions by the parties are:

contribute \$30,000.00 cash.

Steven C. Horbatuck will contribute
\$20,000.00 cash.

6. Frank T. and Doris M. Gologorsky will make periodic payments as necessary to fulfill the partnership's obligation on a real property purchase contract.

7. Steven C. Horbatuck shall not have the power to assign his right as a limited partner.

8. There is no agreement on a partner's termination of his interest in the partnership.

9. Doris M. Gologorsky shall receive a guaranteed payment for her services to the partnership dependent upon the income of the partnership's business.

10. On July 1, 1994, limited partner Steven C. Horbatuck shall have a right to the return of this contribution. This return of contribution shall be in equal monthly installments over a period of ten years with 12% interest.


11. Upon the payment to limited partner Steven C. Horbatuck of his entire contribution, the partnership shall be dissolved and its affairs wound up.
