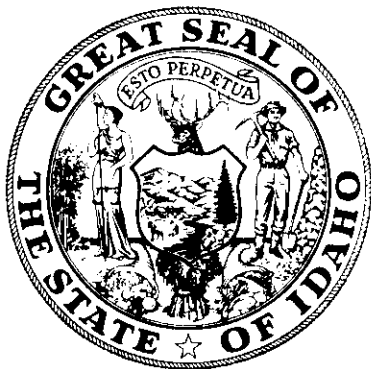

ARTICLES OF INCORPORATION
OF
TERRY'S FARM & BUILDING SUPPLY, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is TERRY'S FARM & BUILDING SUPPLY, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To conduct a business in the sale of farm and building supplies and such other business as is usual, proper, and necessary in such enterprise, together with the transaction of all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, Section 30-1-3.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is Five Thousand (5,000) shares with a par value of Ten Dollars (\$10.00), for a total capital stock of Fifty Thousand Dollars (\$50,000.00), all common stock.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are as governed by the By-Laws.

SIXTH: The address of the initial registered office of the corporation is Post Office Box F, Aberdeen, Idaho, and the name of its initial registered agent at such address is Merle Terry.

SEVENTH: The number of directors constituting the initial board of directors of the corporation is two (2), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:




