ARTICLES OF INCORPORATION (Non-Profit)

GOODING COMMUNITY CHORALE, INC. (GCC)

Article 2:

The Gooding Community Chorale, Inc. (GCC) is organized to bring together community members from across Gooding County and the Magic Valley area to present free of charge cultural, engaging and inspirational musical experiences for local audiences, while encouraging a strong component of community involvement for both patrons in attendance at concerts, local students who will become the future singers, musicians and patrons of GCC, as well as special guest narrators.

Article 4:

Article 5:

The name of the incorporators are again as above.

No part of the net earnings of Gooding Community Chorale shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that GCC shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2 hereof. No substantial part of the activities of GCC shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and GCC shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of the articles, GCC shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or by the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding sections of any future federal tax code.

Article 8:

Upon dissolution of Gooding Community Chorale, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed

to the state of Idaho in the City of Gooding, County of Gooding, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such operated exclusively for such purposes.
