I.

The name of said corporation shall be "CO MAI CO".

II.

(1) To acquire farm and ranch properties and other real estate, by purchase, lease or otherwise, to improve and develop the same, and thereon to plant, sow, cultivate and harvest grains, hay, forage, sugar beets, fruit, potatoes, beans, seed, and all kinds of farm produce and products of the soil. To breed, raise, buy, pasture, prepare for market, exhibit, sell, and deal in livestock of all kinds. To engage in dairying and ranching. To conduct in all their several departments and branches, the business of farmers, fruit growers, dairymen, stock raisers and landleveling and trucking. To do everything incidental or conducive to the full accomplishment of the foregoing objects.

(3) To manufacture, produce, buy, sell, trade and deal in any and all types and kinds of goods, machinery, products, merchandise and personal property of every class and description at wholesale or retail for and on the account of the corporation or as manufacturer, broker, factor, or agent for others.

1 (4) To enter into, make, perform and carry
2 out contracts of every sort and kind with any person,
3 firm or corporation or other legal entity and to
4 acquire and take over the good will, property, rights,
5 franchises, options and assets of every kind and
6 the liabilities of any person, firm, association,
7 corporation or other legal entity either wholly or
8 in part, and to pay for the same in cash, stock,
9 or bonds of the corporation or otherwise.

10 (5) To purchase or acquire property, business
11 rights or franchises or for any other object in or
12 about its business affairs, to incur debt and to
13 borrow and secure the payment of money in any lawful
14 manner, including the issue and sale or other disposition
15 of bonds, debentures, notes or other evidence of
16 indebtedness, and to acquire by purchase, gift, or
17 otherwise, shares of its own corporate stock and
18 cancel the same or any part thereof, or hold all
19 or any of such stock for resale as treasury stock,
20 or for the purpose of making stock dividends to its
21 shareholders and to restrict the transferability
22 of its outstanding shares to the extent reasonably
23 necessary to protect the rights of the corporation
24 and its shareholders in any stock purchase, contracts,
25 or options that may be made between themselves or
26 any of them.

27 (6) To act as surety or creditor in any and
28 all types of engagement, including the power to execute,
29 endorse and deliver contracts and to guarantee the
30 prompt and faithful performance for payment of debts,
31 notes, agreements, contracts and undertakings of
32 any other person, firm, partnership, or corporation,
and to act as accomodation co-maker or guarantor
on obligations either as primary or secondary obligor.

(7) Without in any manner limiting any of the
objects, purposes or powers of the corporation, the
business or purposes of said corporation shall be
from time to time to do any one or more of all of
the acts or things herein set forth.

(8) The several subdivisions contained in this
paragraph of purposes shall be construed as both
purposes and powers and the enumeration thereof shall
not be held to limit or restrict in any manner the
general powers conferred on business corporations
by the laws of the State of Idaho, all of which powers
are hereby expressly claimed.

III.

The corporation shall have perpetual existence.

IV.

The registered office of said corporation in the
State of Idaho shall be located in Murtaugh, Idaho, in the
County of Twin Falls, and that the post office address of the

3 of the corporation is Howard E. Conrad, whose address is Route #1,

7 entirely of stock of no par value and the authorized number
8 of such shares of no par stock shall be One Hundred (100).
9 That all of said stock shall be known as common stock.
