**ARTICLES OF ORGANIZATION  
OF  
DOUBLE H FARMS, A LIMITED LIABILITY COMPANY**

WE, THE UNDERSIGNED natural persons who are at least eighteen years of age and who are the original members, for the purpose of forming a Limited Liability Company under and subject to the provisions of Idaho Code, section 53-602 et seq., hereby adopt the following Articles of Organization.

**ARTICLE I**

**NAME:** The name of the Limited Liability Company shall be DOUBLE H FARMS, A LIMITED LIABILITY COMPANY (hereinafter referred to as the "Limited Liability Company").

**ARTICLE II**

**DURATION:** The Limited Liability Company shall have perpetual existence.

**ARTICLE III**

**PURPOSE:** The purpose for which this Limited Liability Company is organized is to have unlimited power to engage in and do any lawful activity and any activities necessary, convenient, or desirable to accomplish such purpose, and to do all other things incidental thereto which are not forbidden by law or by these Articles of Organization.

**ARTICLE IV**

**RESIDENT AGENT AND OTHER OFFICES:**

**Section 4.02 Principal Office and Maintenance of Records.** The address in the State of Idaho where records will be maintained and the principal office of the Limited Liability Company shall be located at 10101 South Old Highway 191, Malad, Idaho 83252.

**Section 4.03 Other Offices.** The Limited Liability Company may also maintain offices for the transaction of any business at such other places within or without the State of Idaho as it may from time to time determine. Company business of every kind and nature may be conducted, and meetings of managers and members held outside the State of Idaho with the same effect as if in the State of Idaho.

## **ARTICLE V**

### **MANAGER MANAGEMENT:**

**Section 5.01** The management of the Company shall be vested in a manager or managers that must be elected by the members in the manner prescribed in the Operating Agreement for the Company. The number of managers may be increased or decreased in accordance with the terms of the Operating Agreement.

## **ARTICLE VI**

### **OPERATING AGREEMENT:**

## ARTICLE VII

**AMENDMENT:** These Articles of Organization may be amended by the affirmative vote of a majority of the members on each such amendment.
