a natural person, or if more than one, each a natural person of the age of twenty-one years or more, do hereby incorporate a corporation under and pursuant to the laws of the State of Oregon relative to private corporations and hereby do adopt, execute and verify, in duplicate, the following ARTICLES OF INCORPORATION thereof: ARTICLE I.
