



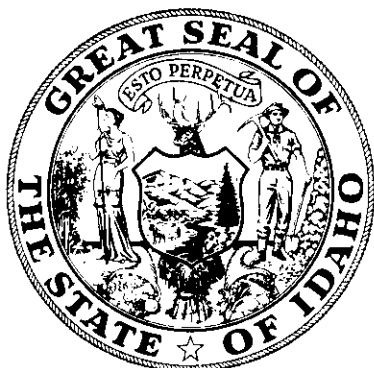

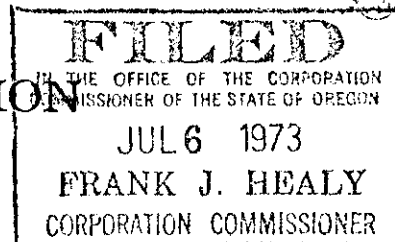

ARTICLES OF INCORPORATION

OF

WEST FORK CONSTRUCTION, INC.



KNOW ALL MEN BY THESE PRESENTS, That William C. Thorp Jr.

a natural person, or if more than one, each a natural person of the age of twenty-one years or more, do hereby incorporate a corporation under and pursuant to the laws of the State of Oregon relative to private corporations and hereby do adopt, execute and verify, in duplicate, the following ARTICLES OF INCORPORATION thereof:

ARTICLE I.

The name of the corporation is WEST FORK CONSTRUCTION, INC.

and the duration thereof shall be perpetual.

ARTICLE II.

The purpose or purposes for which the corporation is organized shall be:

(1) To engage in any lawful activity for which corporations may be organized under Chapter 57 of Oregon Revised Statutes;
