ARTICLES OF INCORPORATION

OF

CLEAN TEAM, INC.

under Section 30-1-54 of the Idaho Code. 20

ARTICLE ONE. The name of the proposed corporation is Clean Team, Inc.

ARTICLE TWO. The corporation shall be organized as a for profit business in the State of Idaho and pursuant to Idaho Code.

ARTICLE THREE. The purpose or purposes for which this corporation is formed, are as follows, to wit:

To carry on all or any of the business of a cleaning and maintenance firm and to do all other things necessary and relating thereto.

To purchase, acquire, hold, and dispose of the stocks, bonds, and other evidences of indebtedness of any corporation, domestic or foreign, and to issue in exchange therefor its stocks, bonds, or other obligations, and to exercise in respect thereof all the rights, powers, and privileges of individual owners, including the right to vote thereon; and to aid in any manner permitted by law any corporation of which any bonds or other securities or evidences of indebtedness or stocks are held by this corporation, and to do any acts or things designed to protect, preserve, improve or enhance the value of any such bonds or other securities or evidence of indebtedness or stock.

To engage in any other lawful business activity that may be necessary to meet objectives that may from time to time be established by the Board of Directors consistent with the by-laws and charter of the corporation.

ARTICLE FOUR The period of duration of the corporation shall be perpetual.

ARTICLE FIVE. The initial registered office of the corporation shall be at 1223 Oak Street, (mailing address P.O. Box 84) in the city of Sandpoint, County of Bonner, State of Idaho. The initial registered agent of the corporation at this address shall be Samuel G. Mahaffy.

ARTICLE SIX. The aggregate number of shares which the corporation shall have the authority to issue is one hundred (100), no par value, consisting of one (1) class only.


ARTICLE SEVEN There shall be three (3) directors constituting the initial Board of Directors. Their names and addresses are: Samuel G. Mahaffy 1223 Oak St. Sandpoint, Id.

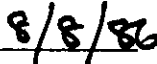

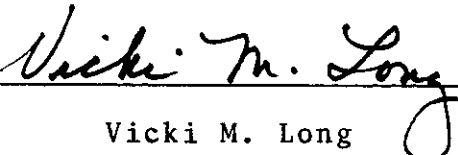
