SEART ART OF STATE ARTICLES OF INCORPORATION OF

BLACK VECTOR CORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

#### ARTICLE I

The name of the corporation is Black Vector Corporation.

## ARTICLE II

The period of its duration is perpeutal.

#### ARTICLE III

The purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

## ARTICLE IV

The total authorized number of par value shares of common stock is 200,000 shares, with par value of \$1.00 per share. The total authorized number of no par shares of preferred stock is 10,000 shares.

Upon dissolution or liquidation of the corporation, the preferred stock shall be redeemed before the common stock is redeemed. This Article shall not be applied in contravention of the corporation laws of the State of Idaho.

#### ARTICLE V

Provisions for the regulation of the internal affairs of the corporation are provided in the by-laws of the corporation.

## ARTICLE VI

The address of the initial registered office of the corporation is 445 No. Capital, Suite 10, Idaho Falls, Idaho 83402; and the name of its initial registered agent at such address is Glenn Don Land.

# ARTICLE VII

The number of directors constituting the initial board of directors of the corporation is three (3), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
