KNOW ALL MEN BY THESE PRESENTS, that JAMES CHARLIE SHEWEY and STAR RENE SHEWEY, husband and wife, and ERIC NOEL SHEWEY, the undersigned, full age citizens of the United States, this day, for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, do hereby certify:

ARTICLE I.

That the name of the corporation shall be SHEWEY ENVIRONMENTAL MANAGEMENT CO., INC.

ARTICLE II.

The purposes for which the corporation is organized shall be, and include, the transaction of any and all lawful business for which a corporation may be incorporated under "The Idaho Business Corporation Act".

ARTICLE III.

This corporation shall have perpetual existence.

ARTICLE IV.

The location and post office address of the registered office in this State and principal place of business shall be 409 Coeur d'Alene Avenue, Coeur d'Alene, Kootenai County, Idaho, and the initial registered agent at such address is JAMES C. SHEWEY.

ARTICLE V.

There shall be only one class of capital stock of this corporation, which shall be designated as common stock, and such common stock shall be and consist of One Million (1,000,000) shares with a par value of ONE DOLLAR AND NO/100 (\$1.00) totaling in the aggregate sum of ONE MILLION DOLLARS AND NO/100 (\$1,000,000).

ARTICLE VI.

The number of directors constituting the initial Board of Directors of the corporation shall be three (3). The number of directors and officers may from time to time be fixed by the bylaws of the corporation at any number.
