KNOW ALL MEN BY THESE PRESENTS, THAT WE, the undersigned being persons of full age and being citizens of the United States, pursuant to the Business Corporation Act of Idaho, do hereby certify to the Secretary of State of the State of Idaho Pursuant to Title 30, Chapter 1, Idaho Code, the undersigned corporation amends its articles of incorporation as follows:

FIRST: The name of the Corporation is World Wide Concepts, Inc.

**SECOND:** The purpose for which the said Corporation is formed is to provide distribution/marketing services for retail/wholesale customers, unaccredited educational programs, and any other lawful business.

**THIRD:** The Corporation is to have perpetual existence.

**FOURTH:** The Corporations' officers will assure that all financial accounts bear the name of the Corporation and have named a minimum of two authorized individuals from the Board.
