BE IT REMEMBERED, That at a legally called special meeting of the shareholders of RIGBY, THATCHER & ANDRUS, P.A., held at the office of said corporation at 25 North Second East, Rexburg, Madison County, Idaho, on the 11th day of September, 1978, which meeting, as will hereinafter more particularly appear from the affidavit of the President and Secretary of the corporation hereto attached, was legally called for the specific purpose among other things of submitting to the shareholders of said corporation the question of the adoption of an amendment to the Articles of Incorporation of said corporation hereinafter specified, at which meeting all of the shares of the outstanding stock of the corporation were represented in person; and by the unanimous vote of all the shares of stock of the corporation a resolution was passed and adopted, so as to change the corporate name of this corporation from RIGBY, THATCHER & ANDRUS, P.A., to RIGBY, THATCHER, ANDRUS, BARTON & WALTERS, Chartered, with said new corporate name wherever the same appears in the Articles of Incorporation, or By-Laws, and to amend Article ONE of the Articles of Incorporation to read as follows:

"The name of said corporation shall be RIGBY, THATCHER, ANDRUS, BARTON & WALTERS, Chartered."

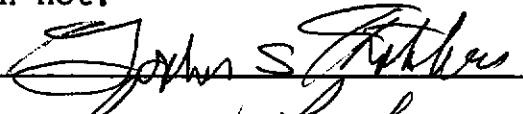
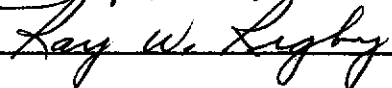
GORDON S. THATCHER and RAY W. RIGBY, being severally duly sworn, each for himself deposes and says:

Rigby is the Secretary of RIGBY, THATCHER & ANDRUS, P.A., a corporation organized and existing under and by virtue of the laws of the State of Idaho since December 31, 1973, the date of its incorporation; that the foregoing amendment to the Articles of Incorporation of RIGBY, THATCHER & ANDRUS, P.A., to change the name of said corporation to RIGBY, THATCHER, ANDRUS, BARTON & WALTERS, Chartered, was adopted by the affirmative vote of all of the shares of outstanding stock of said corporation at a

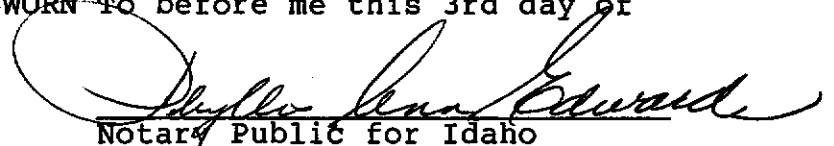
