## ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

 $\overline{\text{FIRST:}}$  The name of the corporation is BIG STEP MINING COMPANY, INC.

SECOND: The period of its duration is perpetual.
