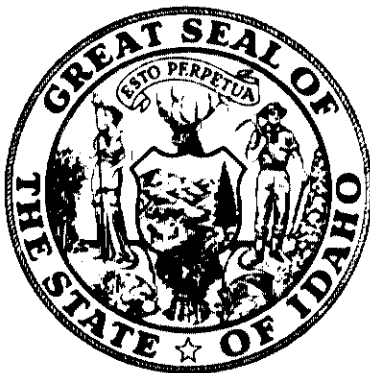

ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
TRI-C DEVELOPMENT, INCORPORATED

In accordance with the provisions of Section 30-1-59, et. seq. of the Idaho Business Corporation Act, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Tri-C Development, Incorporated.

SECOND: The following amendments to the Articles of Incorporation were adopted by the Board of Directors of the corporation on June 15, 1989.

ARTICLES 1 is amended to strike the name TRI-C DEVELOPMENT COMPANY, INC.

There are One Hundred Shares of common stock outstanding. All such shares being entitled to vote on these Amended Articles of Incorporation.

One hundred shares were voted in favor of amending the Articles of Incorporation as stated herein, no shares were voted against the amendment.

Except for the designated amendment, the Articles of Incorporation correctly set forth the provisions of the Articles of Incorporation as amended.


