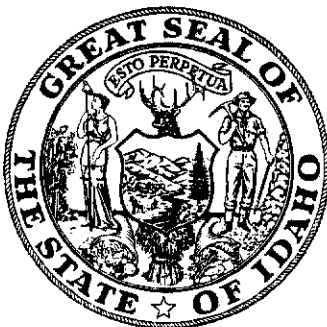

ARTICLE I  
Name

The name of the corporation shall be GARY KAZDA CONSTRUCTION, INC.

The period of duration of this corporation is perpetual.


