i, the undersigned, natural adult person, desiring to form a corporation in the State of Idaho, hereby adopt the following Articles of Jacorporation for such corporation:

STATE OF ICAHO

FIRST: The name of the corporation is "COPPER RIVER SALMON INC.";

SECOND:

The period of its duration shall be perpetual;

THIRD: This corporation shall have unlimited power to engage in and to do any lawful act concerning any or all lawful business for which corporations may be organized under this act;

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is fifty thousand (50,000) shares of no par value common stock;
